##### Green Team

**Program Summary:** Sustainable Highland Park (SHP) is the Green Team for the Borough of Highland Park. It originated from the Green Community Working Group in the early 2000s. SHP meets monthly on the 4th Wednesday of the month at the Environmental Education Center at 20 River Road. All meetings are open to the public. Historically, Sustainable Highland Park has

several projects promoting home composting and community gardens. SHP has organized the Borough's Earth Day events for the last four years, including 2013 (see Green Fair action for details). Its most recent major project is "It's in Our Power Highland Park", which was a two-year EPA Climate showcase Community Grant (with Montclair and Cherry Hill). Among the accomplishments to date, include 244 home audits have been performed and 35 NJHPwES Projects have been completed or scheduled.

## Green Fair

10 Points

**Program Summary:** Highland Park's largest sustainability event (or Green Fair) in 2013 was its Earth Day celebration. The event was held at the borough's Environmental Education Center, which is tucked into nature on the banks of the Raritan River adjacent to a Native Plant Preserve. The effort was spearheaded by Sustainable Highland Park, the borough's Green Team, in partnership with our Main Street organization and Borough Council. The borough supported the event by providing communications assistance, traffic safety police during the course of the day as well as making public works personnel available to prepare the Environmental Education Center building and grounds as well as deliver equipment. The event had several workshops, more than 25 exhibitors, live music and food. With more than 250 people in attendance, Earth Day was a tremendous success and plans have already begun for 2014. ## Community Education & Outreach

**Program Summary:** Following a very successful Earth Day event at the Environmental Education Center in Highland Park, the Borough of Highland Park and Sustainable Highland Park launched a summer Environmental Education Series that is targeted at children and parents, but all are welcome. The first event focused on native wildlife with demonstrations and a bird walk. The second put beekeeping in the spotlight, with a local beekeeper offering a demonstration as well as fielding questions and answers from residents. The borough promoted the event through its website, facebook page, as well as the nixle email service for residents. The summer series took a hiatus in August, but will resume this September on a monthly basis. ## "Green" Your Green Fair \*Retired 12/31/23\*

10 Points

**Program Summary:** Highland Park's 2013 Earth Day (or Green Fair) was born out of an interest in sustainability. The following is a breakdown of how Highland Park "greened" its Green Fair. **ENERGY EFFICIENCY:** The event was held outside at the Environmental Education Center and use of electricity was limited to lighting in the center for the lectures and to power the sound system used by the musicians. **ALTERNATIVE TRANSPORTATION:** Attendees were encouraged to bike, walk or run to the venue (not drive) and traffic safety policy officers were made available to assist in this effort (see uploaded flyer). **LOCAL ECONOMIES:** Food vendor Zaika Grill is a small, newly opened business in neighboring Edison. Musicians were all local to the Highland Park/New Brunswick area as well. **WASTE REDUCTION:** Exhibitors were instructed NOT to bring handouts or other "throwaway" items and Sustainable Highland Park provided a water station and water fountain to reduce dependency on single-use plastic water bottles.

### Municipal Onsite Solar System

10 Points

**Program Summary:** In 2006, solar panels were installed on Highland Park's borough hall using financial incentives from the Board of Public Utilities. The system generates one fourth of the building's energy needs. There was extensive education and promotion about this project, a good example being a gathering of several mayors, council members and state officials at borough hall to view the panels and discuss related energy conservation and sustainability efforts. ### Community Gardens

**Program Summary:** The Highland Park Edible Gardens Project, supported by a \$10,000 grant

from WalMart via the Sustainable Jersey program, enabled the Borough to establish three edible gardens at Irving Elementary School, Bartle Elementary School, and the Middle School/High School. The project involved considerable public outreach and education as well as volunteer, school and borough support. Since April 2010, the school and library gardens have been continuously active in the spring, summer and fall and incorporated into student activities and learning.

## Farmers Markets

10 Points

**Program Summary:** Main Street Highland Park staff manages the Downtown Farmers Market, which will mark its 17th year in 2013. It runs Fridays, mid-June through Dec 20, 11:00 a.m. to 5:30 p.m. in the municipal parking lot between 2nd and 3rd Avenue on Raritan. The New Jersey Council of Farms and Communities (NJ-CFC) inspects and certifies the farmers who participate in the Highland Park Farmers Market. The Highland Park Farmer's Market farmers and vendors feature CERTIFIED Jersey Fresh produce, grown on their own land. The focus of the Downtown Farmers Market is the New Jersey growers. Some vendors, however, sell baked items, cut flowers. There is also an Artisan's Market next door to the Farmers' Market, where artisanal products, jams, preserves, and even a knife sharpener are available. The Borough of Highland Park fully supports the Farmers Market, from providing the location to financially supporting Main Street Highland Park, which helps manage and promote the market. ## Making Farmers Markets Accessible

**Program Summary:** The Highland Park Farmers Market is located between 2nd and 3rd Avenues on the municipal parking lot and is within a 1/2 mile of the New Brunswick train station and a short walk from the NJTransit bus stops on 2nd and 3rd Avenues. Three of the Farmers accept EBT payments, and the borough's Main Street program is in the process of setting up a reader we received through a grant process, so that all vendors can accept such payments. Everyone accepts SNAP/WIC checks, and the Highland Park Market has an innovative voucher program we use together with the HP Food Pantry. Also, Farmers donate unsold produce, etc. to the Food Pantry and/or Elijah's Promise kitchens.

## Building Healthier Communities

**Program Summary:** Highland Park has had an active Mayors Wellness Campaign since 2006 (see attached pledge). The following is a summary of our activities across each of the areas. Youth in Motion: Highland Park created a Walking School Bus in 2007 for Bartle Elementary School, a direct outgrowth of the Mayors Wellness Campaign launch the previous year. The walking bus continues to be active. In addition, the borough's recreation department offers numerous programs for kids (see flyer on recreational activities). Seniors in Motion: The Highland Park Senior Center offers a wide array of programming for the senior citizen community, including relaxations programs, Tai Chi, a drama program and yoga and exercise (see October 2013 calendar) Communities in Motion: The borough recently launched its walking program for adults. They are mid-week themed walks, such as environmental walk through meadows trails (held on July 23 6:30pm, led by Allan Williams, Environmental Commission), Fall foliage Walk, pointing out specimens and discussing them (held on Oct. 20, led by Karen Swain, Shade Tree Committee). The foliage program was so popular a second one was scheduled for the following day (see attached email promotion) - next up will be a historical walking tour of Raritan Avenue on November 7. Employees in Motion: Highland Park recently launched an employee wellness program in conjunction with the Garden State Joint Municipal Insurance Fund (GSJMIF). The first offering, a regular yoga class on Mondays and Fridays from 1-1:30 is now being offered to all employees (see attached flyer).

## Innovative Projects

---

### Innovative Community Project 1

10 Points

**Program Summary:** In 2009, Highland Park gained national recognition by being named the 13th Fair Trade Town in America by Fair Trade Towns USA. Fair-trade practices involve giving farmers or makers of a product, mostly in developing countries, a guaranteed minimum price, safe working conditions and an opportunity to sell directly to importers, eliminating the middleman. Highland Park Councilman Jon Erickson, Who Is My Neighbor? Inc., (WIMNI), a grassroots community agency whose mission is to create neighborly care locally and globally along with Main Street Highland Park pursued the designation. The borough had to meet five criteria before they could be considered for the designation, including: form a steering committee; outreach to area retailers; engaging the community; and gain media attention and to pass a Fair Trade resolution.

### Environmental Commission

10 Points

**Program Summary:** The Highland Park Environmental Commission was established by ordinance (see attachment) in 1968. The EC meets on the 1st Wednesday of the month at 8:00 PM (except for August) at the Highland Park Environmental Education Center, 20 River Road,

Highland Park. The meetings are open to the public. The primary statutory functions of the Environmental Commission (EC) are the following: 1. Review site applications before the Planning Board and the Zoning Board of Adjustment and provide written comments to the appropriate board. 2. Conduct research into the use of open land areas of the Borough, keep an index of all public or private open areas, and make recommendations to the Planning Board and to the Borough Council on plans and programs for the use of such lands. As summarized in the 2012 Annual Report, the EC has successfully competed for grants. The most recent grant was for an Environmental Resource Inventory, which was completed in February 2012. The ERI has been incorporated into the Borough's Master Plan. The EC generated a significant amount of original data for inclusion in the ERI. A significant amount of the county and state data had errors, which were corrected for the ERI. The EC also has built a Trail in the 17 acre Borough owned property "The Meadows", which is in the southeast corner of the Borough, zoned conservation/recreation, and adjacent to the Raritan River. The EC has stewardship over the property. A number of Eagle Scout projects have been performed under the guidance of the EC and include construction of wooden benches and boardwalks. The EC has a website ([www.leoraw.com/hpenv/](http://www.leoraw.com/hpenv/)), which includes monthly bird sighting in Highland Park.

## Natural Resource Inventory

20 Points

 Bronze Priority  Silver Priority

**Program Summary:** In 1992, the Environmental Commission (EC) generated a Natural Resources Inventory. In March of 2010, the EC applied for and received an ANJEC grant to write an Environmental Resource Inventory (ERI). A project team was established with member from multiple boards and a councilman. The project team contracted with Kratzer Environmental Services to generate the ERI. One of the reasons that Kratzer was chosen was her willingness to customize the ERI for Highland Park, to integrate information from past EC's historical studies, and to have the project team draft the Historical Resources section. One significant problem, we encountered was that Middlesex County Planning had not generated a digitized tax map (by Block and Lot) for the Borough. Thus, to generate maps of building of historical interest, the project team had to gather GPS data. Similarly for a section on tree species, GPS data was gathered. Review of county and state GIS data revealed significant errors or absence of data. Numerous outfalls were not included, half of street names were incorrect, and local streams were missing. Additional GPS data was generated and corrections made. It was noted that residential properties were included in DEP Brownfield databases and DEP contaminated site data layers were out of date (as long as 5 years). DEP databases on line were more accurate. The major lesson from generating the ERI was to check all data from all sources. The ERI was completed in February 2012. The ERI was incorporated into the Borough's Master Plan in February 2012. Copies of the ERI were distributed to the municipal boards, municipal offices, libraries, and Middlesex County Planning. The Borough's planner requested and received a copy. The Environmental Commission has found the ERI vary useful in assessing site applications.

### Community Energy Plan or Climate Action Plan

**Program Summary:** With the support of the Sustainability Institute at the College of New Jersey, Highland Park along with Cherry Hill and Montclair secured a Climate Showcase Communities Grant from the USEPA. As part of this project, Highland Park performed both a municipal and community carbon footprint in order to develop attainable carbon reduction targets for the community. This work was pulled together in the form a Highland Park's Energy Plan, which sets



forth a 4 percent annual reduction goal along with the steps that can be taken to achieve them across a variety of sectors - municipal, residential (renters and homeowners), commercial and schools. The borough adopted the targets set forth in the Energy Plan at the July 5, 2011 Council Meeting with resolution 07-11-198 (see attached minutes, page 6).
